# WHAT IS CERTHE?

SZABIST, a Recognised Teaching Centre of the University of London, is delighted to have been granted Certificate Teaching Status by the University of London which enables us to offer another route to the LLB Degree through the Certificate of Higher Education in Common Law (CertHE).

Certificate of Higher Education in Common Law (CertHE) is a qualification in its own right that also provides an entry route to degree-level study.

It is ideal if you are ready to study for a degree but do not have the qualifications usually required to enter.

SZABIST now offers an opportunity to students with Intermediate (HSC) backgrounds or O/A Level grades short of the requirement for LLB to begin with the UoL Law Degree as CertHE in 1st Year. Those willing to continue can transfer to the LLB thereon and can complete the LLB in a total of three years.

CertHE students will take the same 4 modules that are a part of the 1st year course of the LLB. The only difference, then, is that the CertHE students will receive additional tuitions in English Language and Study Skills to support them with the course.

## **Admission Requirements**

To be eligible to register for this CertHE programme, you must be at least 18 years of age and one of the following should be applicable:

- Pass in Intermediate with minimum 55% in total OR
- 6 passes in GCE O-Level

#### **Entrance Tests & Interview**

If you fulfill the admissions requirements as above, you must also pass the two tests conducted by University of London and SZABIST respectively. Once you have passed these tests, the last requirement before registration is to pass is an interview conducted at SZABIST.

### **Introduction of Day Program**

For the first time, SZABIST is planning to introduce LLB and CertHE classes in the day as well to cater to students who prefer to attend classes during the afternoon. The evening classes shall also continue as per the norm. Applicants to SZABIST, Faculty of Law will have the option of applying for either the afternoon or evening programme, depending on their preference.
